To: Producers interested in selling in PCFMA's Certified Farmers' Markets

Re: Applications for 2012 Markets

Thank you for your interest in selling your products within the farmers' markets operated by the Pacific Coast Farmers' Market Association.

PCFMA operates only *certified* farmers' markets, which means that all certifiable agricultural products – fruits, nuts, vegetables, eggs, herbs, nursery stock and honey – may only be sold by the producers themselves. Buying and reselling is not allowed. PCFMA applies this principal to other items sold at the market such as hot food, pastries, breads and sauces. We encourage participation by producers of these products but typically do not allow access to the market by distributors. PCFMA also allows non-food or craft items only in certain markets and under certain conditions. If you wish to sell craft items please contact PCFMA's Market Operations Manager, Vince Scalise, at 925-825-9090 to request the appropriate application.

To sell in PCFMA's farmers' markets in 2012, you need to complete the Application to Sell and return it as soon as possible with your application fee.

Be sure to complete the Market Reservation Request and include it with your application. If you have current copies of your paperwork (certificates, insurance, health permits, etc.) include them with your application. If you do not yet have current copies, please send in your application as soon as possible and send the additional paperwork once it arrives.

PCFMA's stall fees for 2012 vary by season and type of producer:

	Winter Rates (December thru March)	Summer Rates (April thru November)
Agricultural Producer	\$25	\$35
Non-Agricultural Producer Pre-Packaged Products	\$40 or 6% of sales if sales exceed \$667	\$50 or 6% of sales if sales exceed \$833
Non-Agricultural Producer Processing at the Market	\$50 or 6% of sales if sales exceed \$833	\$60 or 6% of sales if sales exceed \$1000

The above rates are for a single 10 foot by 10 foot stall. Rates are charged according to the amount of space used at the market: if you use a stall and a half you will be charged one-and-a-half times the appropriate rate. If you use two stalls, you will be charged at twice the appropriate rate, etc.

The application requires your signature by which you attest to having read PCFMA's published 2012 Rules and Regulations and by which you agree to abide by those rules. Please take some time to become familiar with the 2012 Rules and Regulations as there have been a few changes. A copy of the Rules and Regulations is enclosed and they are also posted on our website at www.pcfma.com/resources.php.

Please note that your general liability insurance must have minimum coverage of \$500,000, and must name Pacific Coast Farmers' Market Association as additional insured.

Application Checklist

- \$100 Application Fee (**This fee is a processing fee and is non-refundable and is not a guarantee that we will be able to reserve you in any of our markets.**)

Note: For producers who sold in PCFMA's farmers' markets in 2011, the application fee increases to \$125 after February 24, 2012.

- Current Certificate of General Liability Insurance naming PCFMA as Additional Insured
Note: Minimum coverage \$500,000. If you are a new producer, you may wait until you receive your reservation letter before buying insurance as this application does not guarantee placement in any markets.
- Certificate of Auto Insurance
- Valid Certified Producer's Certificate

Additionally, send all of the following that apply:

- List of non-certifiable agricultural products
- Processing Facility's Health Permit (For non-certifiable agricultural products)
Note: Non-certifiable agricultural products are defined as juices, jams, shelled nuts, farmed seafood, meat, and animal products.
- Organic production documentation from certifying agency
- Organic Registration from the State of California
- California License to Sell Nursery Stock
- \$100 Second Certificate Application Fee
Note: For producers who sold in PCFMA's farmers' markets in 2011, the application fee increases to \$125 after February 24, 2012. Additionally, both certificates must be cross-referenced listing both farms.
- Valid Second Certified Producer's Certificate
- Letter from the original holder of the second certificate granting authorization for you to sell their product
- Seller's Permit if you are selling any taxable items

Stall Fee Structure

December-March: \$25 for a 10x10 foot stall

April-November: \$35 for a 10x10 foot stall

2nd Certificate: \$15 regardless of season

Note: A stall is defined as 10 feet by 10 feet. If you occupy a 20 foot by 10 foot space, you will pay a double stall fee. If you occupy a 30 foot by 10 foot space, you will pay a triple stall fee, etc.
